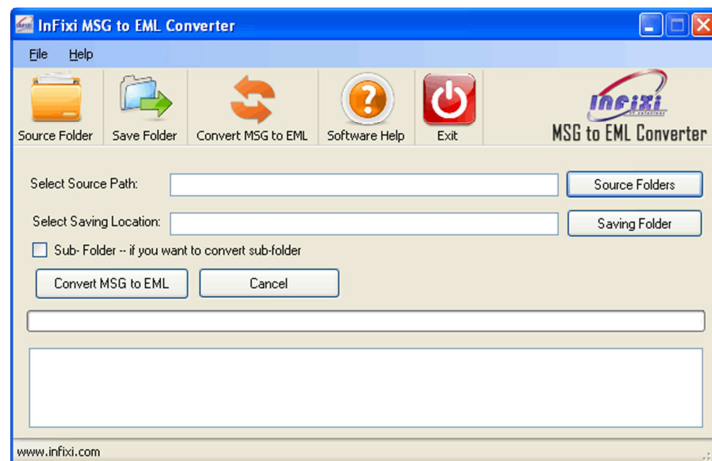

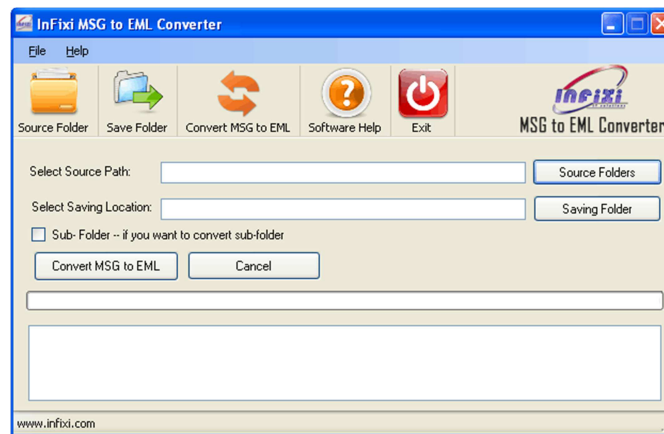

Software Help - See software help.



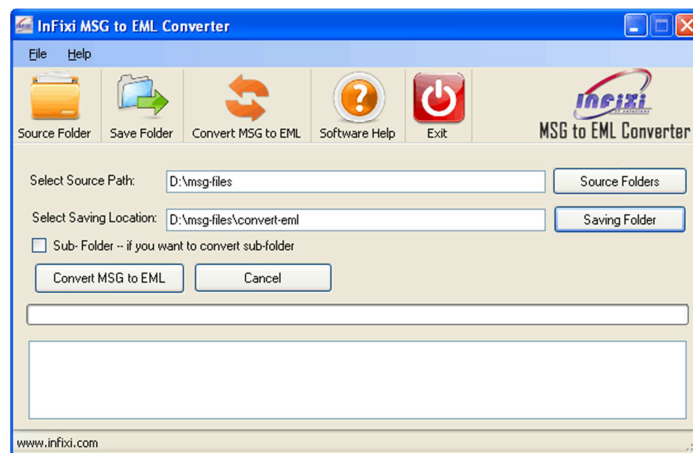
Exit - Click to Exit from Software.

Further steps to convert MSG to EML format

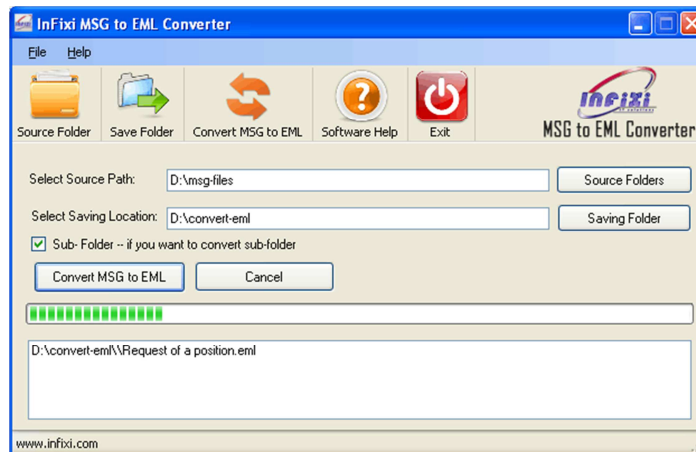
- Click on **Source Folder** button (or from toolbar) and select your MSG file from your computer hard drive.
- Now Click on **Saving Folder** (or from toolbar) and choose the location where you want to convert MSG files in EML format.

Now software looks like something-



If you have more folders inside your selected Source Folders, then you can select the checkbox Sub- Folder -- if you want to convert sub-folder to perform batch operation.

- Click on **Convert MSG to EML** button (or from software toolbar) to start the conversion process.
